Nondeductible Dues

- Individuals who belong to a not-for-profit Association may not deduct for income tax purposes the portion of their 2025 Membership dues spent on federal, state, or local lobbying activities. Please click here for the nondeductible amounts. The total nondeductible amount does not include voluntary ROAC contributions. RPAC contributions are not deductible amounts.
- Membership dues are not deductible as charitable contributions, but may be deductible as an ordinary and necessary business expense subject to restrictions imposed as a result of Association lobbying activities.

Secondary Membership is available to REALTORS® who already have primary Membership in another REALTORS® Association and wish to join RASCW also. If you have already paid your 2025 State (WRA) and/or National (NAR) dues through another REALTORS® Association, you do not need to pay them again if joining here as a secondary member or if transferring here from another REALTORS® Association.
